Loading Doors:

- There are **2 entrances** for loading into and out of the theater, located on Bank Street between Greenwich Street and Washington Street.
 - **Front Door:**
 - Width: 3'-4"
 - Height: 6'-10"
 - Access to stage through the audience aisle; anything over 29" wide must be lifted over the audience railing.
 - **Garden Gate:**
 - Located just west of the theater
 - Width: 3'
 - Height: 6'-11"
 - Leads to three doors leading to backstage (ranging from 2'-5" to 2'-11" wide by 6'-6" tall).

Storage Space:

- The theater does not provide additional storage space.
-

Flameproofing and Stage Fire Regulations:

- Under NYC law, all scenery must be flameproofed according to Chapter 8 of the NYC Fire Code.
- Proof of flameproofing required prior to performances, including:
 - Notarized affidavit by an approved FDNY certificate holder
 - Certificate of Fitness holder's name, CoF number, and expiration date
 - Date of flameproofing treatment
 - Name of flameproofing treatment used
 - Board of Standards and Appeals approval number/FDNY approval number
 - Warranted period of flameproofing effectiveness
 - Confirmation of testing meeting established standards

Note: Inherently flame-resistant without an affidavit is no longer accepted by FDNY.

- A flameproofing/safety inspection may be necessary prior to any performance.

Theater Restore & Trash Removal:

- Renter responsible for restoring space to original configuration (lighting rep plot, repainting stage and walls with Valspar Medallion Semi-Gloss Black #4315).

- At rental completion, all trash, scenery, and props must be removed from theater property.
 - Renter must arrange for removal of items/trash; dumpster and removal services can be arranged at renter's cost.
 - Disposal plan must be approved prior to renter's load-in.

Phones:

- The theater does not provide production telephone lines.
 - Cell phone service for most carriers is consistent throughout the theater space.
-

Garden:

- The Garden is available and can function as a green room during good weather.
-

Internet:

- Wireless internet is available throughout the theater and dressing rooms.
-

Front Of House Information:

- **Seating Capacity:** 59 max
 - 54 Permanent Seats
 - 5 Removable Seats (first row, can be removed for wheelchair seating)
 - 2 Removable seats (last row)
 - **Building Capacity:** 74 people total, including audience, cast, and crew members.
 - **Audience Entrance:** Through the front door at 124 Bank Street (Between Greenwich and Washington Streets).
 - **Box Office:** Location in the lobby area provided (BOX OFFICE STAFF AND SERVICES MUST BE PROVIDED BY CLIENT).
 - **Bathrooms:** 2 single, unisex bathrooms located in the lobby.
 - **Small concessions** area in the lobby.
 - **Trash Removal:** Renter responsible for removing excessive trash from the lobby or backstage to outside garbage bins in front of 122 Bank St.
